#### Basic Benefits for Plans A–J:

Hospitalization: Part A coinsurance plus coverage for 365 additional days after Medicare benefits end.

Medical Expenses: Part B coinsurance (generally 20% of Medicare-approved expenses) or copayments for hospital outpatient services.

Blood: First three pints of blood each year.

\* Plans F and J also have an option called a high-deductible Plan F and a high-deductible Plan J. These high-deductible plans pay the same benefits as Plans F and J after one has paid a calendar year \$2,000 deductible. Benefits from high deductible Plans F and J will not begin until out-of-pocket expenses are \$2,000. Out-of-pocket expenses for this deductible are expenses that would ordinarily be paid by the policy. These expenses include the Medicare deductibles for Part A and Part B, but does not include the plan's separate foreign travel emergency deductible.

The out-of-pocket annual limit does NOT include charges from your provider that exceed Medicare-approved amounts, called "excess charges." You will be responsible for payment of excess charges.**

We, Medical Mutual of Ohio<sup>®</sup>, can only raise your premium if we raise the premium for all policies like yours in Ohio. We determine your premium based upon attained age. This means your premium will increase each year.

### **Disclosures**

### **Read Your Policy Very Carefully**

This is only an outline describing your policies most important features. The policy is your insurance contract. You must read the policy itself to understand all of the rights and duties of both you and your insurance company.

### **Right to Return Policy**

If you find that you are not satisfied with your policy, you may return it to Medical Mutual at our local address listed below. If you send the policy back to us within 30 days after you receive it, we will treat the policy as if it had never been issued and return all your payments.

### **Policy Replacement**

If you are replacing another health insurance policy, do not cancel it until you have actually received your new policy and are sure you want to keep it.

### **Notice**
