Proper Documentation and Coding to Accurately Capture Prenatal and Post Partum Care for the HEDIS PPC Measure

The Healthcare Effectiveness Data and Information Set (HEDIS®) measure Prenatal and Postpartum Care (PPC) developed by the National Committee for Quality Assurance (NCQA) assesses the percentage of deliveries of live births on or between October 8th of the year prior to the measurement year and October 7th of the measurement year. For these members, the measure assesses the following facets of prenatal and postpartum care:

- Timeliness of Prenatal Care The percentage of deliveries that received a prenatal care visit in the first trimester on or before the enrollment start date or within 42 days of enrollment in the organization.
- Postpartum Care The percentage of deliveries that had a postpartum visit on or between 7 and 84 days after delivery.
